**Paper 1: The Role of LULUCF Activities in International and National Climate Policies**

The purpose of this paper is to explain the current international “rulebook” on LULUCF as laid down in the Kyoto Protocol and the Marrakech Accords, and whether and how LULUCF activities are being or are likely to be implemented nationally.

**Paper 2: How can carbon credits from CDM afforestation and reforestation projects be used by Annex I governments and companies?**

This paper outlines a number of options to use ICERs generated by CDM projects as well as options to internalize the risk of premature release of carbon stocks and thus of project failure before the end of the project’s crediting period. This paper was also published in the CDM Investment Newsletter No.3/2004. Reference is made to the EC-funded INSEA Project.

**Paper 3: Options for including AFOLU activities in a post-2012 international climate agreement**

The purpose of this paper is to provide a platform, stimulate discussion and ultimately develop some sort of consensus amongst experts on options related to Agriculture, Forestry and Other Land Use (AFOLU) for the second commitment period. This paper is circulated in successive drafts, and experts are invited to contribute. The draft paper will be presented at the German LULUCF post 2012 Workshop in September 2004.
